Adopt an Ordinance adopting the Standard Traffic Ordinance for Kansas Cities.

Burch moved to adopt Ordinance No. 706 AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE CITY LIMITS OF THE CITY OF OGDEN, KANSAS; EDITION OF 2015, WITH CERTAIN OMISSIONS, CHANGES AND ADDITIONS; PRESCRIBING ADDITIONAL REGULATIONS; PROVIDING CERTAIN PENALTIES AND REPEALING ORDINANCE NO.701 AND ALL OTHER ORDINANCES IN CONFLICT THEREWITH. Seconded by Graham. Motion carried.

Adopt an Ordinance adopting the Uniform Public Offense Code.

Carroll moved to adopt Ordinance No. 707 AN ORDINANCE ADOPTING THE UNIFORM PUBLIC OFFENSE CODE FOR THE CITY OF OGDEN, KANSAS AND REPEALING ORDINANCE NO. 702, AND ALL OTHER ORDINANCES IN CONFLICT THEREWITH. Seconded by Burch. Motion carried.

Clerk commented the he is preparing to assess approximately \$18K in mowing specials to the RIM properties.


