The meeting was called to order at 7:00 p.m.

The following members were present: Roger Graham, Ken Carroll, Ed Burch, Eladio Reid and Mayor Pence. Jim Arp was not present.

Mayor Pence invited the public to present comments to the Governing Body.

Lieutenant Friedline with RCPD presented the Council with a data sheet that showed citations, warnings and accidents on Elm Street from July 2012 to present.

Approval of Agenda:

Burch moved to approve the Agenda. Seconded by Carroll. Motion carried.

Approval of Minutes:

Burch moved to approve the minutes from the 7/1/15 Council Meeting. Seconded by Reid. Motion carried.
