The meeting was called to order at 7:00 p.m.

The following members were present: Roger Graham, Ken Carroll, Jim Arp, Ed Burch and Mayor Pence. Attorney Irvine was present. Eladio Reid was not present.

Mayor Pence invited the public to present comments to the Governing Body.

Approval of Agenda:

Burch moved to approve the Agenda. Seconded by Arp. Motion carried.

Approval of Minutes:

Carroll moved to approve the minutes from the 12/16/15 Council Meeting. Seconded by Burch. Motion carried.

Kimberly Rendon; Request Occupational License for Pizza Hut at 523 Riley Ave.

Burch moved to approve an Occupational License for Pizza Hut at 523 Riley Ave. Seconded by Carroll. Motion carried.

Adopt an ordinance allowing chickens within the City Limits.

Eladio Reid arrived for the meeting at 7:10 p.m.

Graham commented that he was in favor of allowing chickens for the school only.

Carroll moved to adopt Ordinance number 710. AN ORDINANCE AMENDING ARTICLE 1 OF CHAPTER 2, SECTION 2-109 OF THE CODE OF THE CITY OF OGDEN, KANSAS, PERTAINING TO KEEPING ANIMALS. Seconded by Reid. Carroll, Reid and Burch voted in favor. Graham and Arp voted against. Motion carried.

Adopt an Ordinance Designating No Parking in the 100 & 200 Blocks of North Elm Street.

Arp moved to adopt Ordinance number 712. AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE CITY LIMITS OF THE CITY OF OGDEN, KANSAS, BY ESTABLISHING CERTAIN PARKING RESTRICTIONS ON NORTH WALNUT STREET WITHIN THE CITY, AND AUTHORIZING THE ERECTION OF SIGNS SUPPORTING THE SAME. Seconded by Burch. Motion carried.

City Foreman: Misc. Items.

Nations commented that the soft starter for the well pump in well #2 has quick working and needs replaced. Nations presented the Council with a proposal from Economy Electric in the amount of \$4400 to replace it.

Burch moved to accept Economy Electric's proposal and authorize the expenditure of \$4400 to replace soft starter for well pump in well #2. Seconded by Reid. Motion carried.


Carroll commented that he wanted to get a free estimate from a metal building company to do an addition to the Community Center for storage.
