The Regular Meeting of the Governing Body for the City of Ogden was scheduled on Wednesday, June 17, 2015 at 7:00 p.m.

The meeting was called to order at 7:00 p.m.

The following members were present: Roger Graham, Ken Carroll, Ed Burch and Mayor Pence. Attorney Irvine was present. Jim Arp and Eladio Reid were not present.

Mayor Pence invited the public to present comments to the Governing Body.

Approval of Agenda:

Mayor Pence commented that Agenda item 3 needed to be changed to include occupational license.

Burch moved to approve the Agenda with the revision. Seconded by Graham. Motion carried.

Approval of Minutes:

Carroll moved to approve the minutes from the 6/03/15 Council Meeting. Seconded by Burch. Motion carried.

Ricky Stewart; Request Alcoholic Liquor License and Occupational License for Rick's Retail Liquor LLC at 104 Riley Avenue.

Carroll moved to grant Ricky Stewart a Retail Liquor License and Occupational License for Rick's Retail Liquor LLC at 104 Riley Avenue, Contingent upon passing inspection from the Fire Marshal. Seconded by Burch. Motion carried.

Consideration of Ordinance Number 706. An Ordinance placing Stop Signs at 9th, 12th, 13th and 14th and Elm Streets.

Attorney Irvine commented that he wasn't prepared to go against the advice and recommendations of the City Engineer and would recommend that the City not go forward with erecting the Stop Signs. He commented that going against the recommendation of the City Engineer could possibly present liability issues for the City in the future.

Graham commented that he was not in favor of stop signs on 9th and 12th streets, but was in favor of stop signs on 13th and 14th streets.

Attorney Irvine commented that from a legal perspective he felt that there is risk for the city if the Governing Body does anything contrary to the City Engineers opinion.
