Mayor Pence invited the public to present comments to the governing Body.

Approval of Agenda:

Burch moved to approve the Agenda. Seconded by Reid. Motion carried

Approval of Minutes:

Burch moved to approve the minutes from the 2/21/18 Council Meeting . Seconded by Rohlman. Motion carried.

Russell Shipley, Sink Gordon & Associates; Presentation of the 2017 Audit.

Shipley presented the Governing Body with a copy of the 2017 Audit. He commented that there were no problems found during the audit and no adjustments were made.
