The Regular Meeting of the Governing Body for the City of Ogden was scheduled on Wednesday, August 17, 2016 at 7:00 p.m.

The meeting was called to order at 7:00 p.m.

The following members were present: Roger Graham, Ken Carroll, Eladio Reid and Mayor Pence. Attorney Irvine was present. Jim Arp and Ed Burch were not present.

Mayor Pence invited the public to present comments to the governing Body.

Approval of Agenda:

Mayor Pence commented that the minutes were accidentally deleted from the August 03, 2016 Meeting and will be presented at the next meeting for approval.

Carroll moved to approve the Agenda minus the Approval of the Minutes. Seconded by Reid. Motion carried.

Discussion of City Park as future location of Fire Station.

Council listened to comments from citizens in attendance. The consensus of those in attendance was not to put the fire station in the City Park.

The consensus of the Council was to not consider the City Park for the future location of the fire station.

Adopt an ordinance amending Article 3 Chapter XIII of the code of the City of Ogden, Kansas, pertaining to trees and shrubs.

Attorney Irvine commented that the time frame the Council wanted in the ordinance is in the preceding Section 13-302, which gives the Governing Body authority to set a time frame in a case by case basis.

Nations commented that the 2008 Ford needed new tires and presented the Council with a quote from Burnett Automotive for \$630.43 for four tires and a front end alignment.


Reid moved to accept the quote from Burnett Automotive. Seconded by Carroll. Motion carried.
