The meeting was called to order at 7:00 p.m.

The following members were present: Roger Graham, Ken Carroll, Ed Burch, Eladio Reid, and Mayor Pence. Attorney Irvine was present. Jim Arp was not present.

Mayor Pence invited the public to present comments to the governing Body.

Mayor Pence requested that an Executive Session for Land Acquisition Matters be placed between Agenda items #6 and #7.

Approval of Agenda:

Carroll moved to approve the Agenda with the addition. Seconded by Burch. Motion carried.

Approval of Minutes:

Burch moved to approve the Minutes from the 10/05/16 and 10/19/16 Council Meetings. Seconded by Reid. Motion carried.

Review of Tree Contract Proposal.

Nations presented the Council with a proposal from Wildcat Tree for \$1100 per day for Tree Trimming.

Carroll moved to authorize the expenditure of \$2200 to Wildcat Tree Service for two days of tree trimming. Seconded by Burch. Motion carried.

City Foreman: Misc. Items.

Nations commented that there is a problem with numerous vehicles parking in the 300 block of 11<sup>th</sup> Street on the south side of the street. He commented that this is an area that the City had cleaned up and would like the Council to take a look at to see if something could be done to prevent what is currently taking place.

Nations requested some direction from the Council on the street painting/stripping on Riley Ave.

Carroll moved to have the City Crew put up the illegal turning barriers and continue painting turn lanes and stripping throughout Riley Ave. Seconded by Graham. Motion carried.

Carroll moved to recess into Executive Session for the purposes of Land Acquisition Matters until 7:35 p.m. Seconded by Burch. Motion carried.


Carroll moved to return to Regular Session. Seconded by Burch. Motion carried.
