The Regular Meeting of the Governing Body for the City of Ogden was scheduled on Wednesday, June 21, 2017 at 7:00 p.m.

The meeting was called to order at 7:00 p.m.

The following members were present: Roger Graham, Ken Carroll, Jim Arp, Ed Burch, Eladio Reid and Mayor Pence. Attorney Irvine was present.

Mayor Pence invited the public to present comments to the governing Body.

Approval of Agenda:

Burch moved to approve the Agenda. Seconded by Carroll. Motion carried.

Approval of Minutes:

Carroll moved to approve the Minutes from the 06/07/17 Council Meeting. Seconded by Burch. Motion carried.

Director Brad Schoen, Riley County Police Department; Discussion with Governing Body and Citizens.

Director Schoen commented that he tries to make it to a Council Meeting once a year to introduce himself and answer any questions from the Governing Body and Citizens in attendance. He commented that he wanted anyone in the city to feel to contact him personally with any concerns they have or issues that may arise in the future. He commented that citizens can call him at the RCPD or reach him by email at bschoen@rileycountypolice.org. Director Schoen commented that statistically crime in Ogden is down.

Burch moved to Adopt Resolution number 06-21-17A. Seconded by Reid. Motion carried.

Consider quote to repair or replace awning at swimming pool.

Nations commented that the options presented by two Councilmen weren't roof top mounted awnings and would have to be mounted on the fascia board on the roof. He commented that this presented a problem because the awnings wouldn't be high enough to prevent patrons from hanging on them. He commented that the Council could consider the other two options of replacing the existing canvass for \$3154, cautioning that the existing mechanism was 17 years old. Or replace the awning with a permanent structure for \$4936.

Arp moved to accept J C Seamless guttering's proposal to build a permanent 33'x 8' awning for \$4936. Seconded by Burch. Motion carried.

Ken Carroll, VFW, Request for Sale of Fireworks Permit in the City Park and Donation towards Fireworks Night Display.

Arp moved to approve the VFW's request for Sale of Fireworks Permit in the City Park and waive subsequent fee and to allow the discharge of fireworks in the City Parks July 1-4. And to approve a \$750 donation to the VFW for their Fireworks Night Display. Seconded by Reid. Motion carried.

Discussion of drafting an Ordinance lowering the Speed limit on Riley Avenue from 30 mph to 20 mph.

Attorney Irvine commented that since Riley Ave is a business district, the city could lower the speed limit to 20mph without doing an Engineering Study. He also commented should the City decide later to raise the speed limit, then it would require an Engineering Study.

Council discussed contacting Fort Riley as well as KDOT to see if they would have any concerns or issues should the City decide to lower the speed limit to 20mph.

Attorney Irvine commented that an ordinance would need to be adopted should the Governing Body decide to change the speed limit.

Attorney Irvine commented that he would draft an ordinance to be considered at the next meeting.

Discussion of drafting an Ordinance prohibiting loitering and panhandling in certain locations within Ogden.

Attorney Irvine commented that there are significant issues with drafting a panhandling ordinance. He commented that he checked with the City of Manhattan and they didn't have a panhandling ordinance.

Consensus of the council was not to pursue an ordinance at this time and to enforce current regulations to deal with the problems.
