The Regular Meeting of the Governing Body for the City of Ogden was scheduled on Wednesday, July 16, 2014 at 7:00 p.m.

The meeting was called to order at 7:02 p.m.

The following members were present: Ken Carroll, Paul Werle, Ed Burch, Brian Still and Mayor Pence. Attorney Irvine was present.

Mayor Pence invited the public to present comments to the Governing Body.

Approval of Agenda:

Mayor Pence requested that an Executive Session for Non-Elected Personnel be placed between Agenda items 8 & 9.

Burch moved to approve the Agenda with the addition. Seconded by Still. Motion carried.

Approval of Minutes:

Still moved to approve the Minutes of the July 2, 2014 Council Meeting. Seconded by Burch. Motion carried.

Jodi Reid, Community Center Coordinator, Request City Donation for Fall Festival.

Burch moved to donate \$700.00 to the Fall Festival. Seconded by Carroll. Motion carried.

Jodi Reid, Community Center Coordinator: Request for Special Event Cereal Malt Beverage permit for the Ogden Fall Festival Committee and waiver of subsequent fee.

Burch moved to grant a Special Event Cereal Malt Beverage Permit for the Ogden Fall Festival Committee and to waive subsequent fee. Seconded by Carroll. Motion carried.

Nations commented that the welder they have at the shop is for small jobs and is difficult to use. He inquired about purchasing a stick welder, commenting that it would be easier for all of the crew to use.

Burch commented that the dugouts need raised and have some type of protective edge put on them.

Burch commented that the crosswalks need to be painted before school starts.

Burch commented that City needs to contact Maplewind about taking care of their alleys as they agreed to do.

Burch commented that the house located at 514 14th street has a lot of trees that are over grown and have become a nuisance to the neighborhood. He commented that something legally needs to be done to remedy the nuisance.


