Review quote for micro surfacing Riley Avenue.

Clerk presented Council with a quote from Vance Brother Inc., Kansas City, Missouri in the amount of \$66,980 micro surface Riley Avenue. Clerk commented the funding of the project would come from the Special Highway Fund and General Fund.

Clerk commented that the micro surfacing is 1/2 inch thick and supposed to last 7-9 years. He commented that Vance Brothers has indicated that they would be doing the project on a weekend because of Fort Riley traffic.

Burch moved to authorize the expenditure of \$66,980 to Vance Brothers for the micro surfacing of Riley Avenue. Seconded by Carroll. Motion carried.

Review quotes for the striping of Riley Avenue.

Clerk presented Council with quotes for the pavement markings of Riley Avenue following the micro surfacing. Road Safe Traffic Systems quoted \$10,624 to paint the pavement markings. Twin Traffic Marking Corp. quoted \$8,262. to paint the pavement markings.

Nations commented that the painting of the pavement markings would take place one week following Vance Brothers to allow the micro surfacing to cure before painting.
