Lynn Blecha; Present proposal to repair drainage culvert in the 100 block of South Walnut Street.

Blecha presented Council with plans to repair a culvert in the 100 block of South Walnut Street with a total material cost of \$1454 plus labor. Blecha proposed that the City pay for the materials and he would provide the labor and design.

Council discussed as to whether the drive/culvert is the responsibility of the adjacent property owner or the City's responsibility. Council discussed that this location provided access to a proposed new Teen Center for the Ogden youth.

Carroll moved to authorize the expenditure of \$1454 for the repair of the drainage culvert/drive based on the opinion that the repair would help stabilize the walls on the drainage ditch in the 100 Block of South Walnut. Seconded by Burch. Jacobs did not vote. Motion carried.


