The Regular Meeting of the Governing Body for the City of Ogden was scheduled on Wednesday, May 20, 2020 at 7:00 p.m.

The meeting was called to order at 7:00 p.m.

The meeting was held at the Ogden Community Center.

The following members were present: Charles Heath, Ken Carroll, Quinn Jacobs, Ed Burch, Rosio Duarte. Mayor Pence was present. Attorney Irvine was present.

Approval of Agenda:

Burch moved to approve the Agenda. Seconded by Carroll. Motion carried.

Approval of Minutes

Carroll moved to approve the minutes from the 05/06/20 Council Meeting. Seconded by Burch. Motion carried.

John Ford, Riley County Commissioner; Discuss Sales Tax Proposal.

Ford commented that the 1/2 % county wide sales tax is set to expire in 2023. He commented that there has been some discussion on placing a new sales tax on the ballot in November or waiting until the next election cycles in 2021 or 2022 to try and renew the 1/2 sales tax.

Consensus of the Council was not to put the question on the ballot this year.

Nations presented the Council with plans presented and prepared by Lynn Blecha to fix the erosion of the driveway. Nations commented that he could attempt to fix the problem with the plans.

Council discussed when to open public facilities.


Consensus of the Council was not to open to the public until after the 6/3/20 Council Meeting.
