The Regular Meeting of the Governing Body for the City of Ogden was scheduled on Wednesday, July 18, 2018 at 7:00 p.m.

The meeting was called to order at 7:00 p.m.

The following members were present: Russell Rohlman, Ken Carroll, Quinn Jacobs, Ed Burch, Eladio Reid and Mayor Pence. Attorney Irvine was present.

Mayor Pence invited the public to present comments to the governing Body.

Approval of Agenda:

Burch moved to approve the Agenda. Seconded by Carroll. Motion carried

Approval of Minutes:

Carroll moved to approve the minutes from the 6/20/18 Council Meeting. Seconded by Jacobs. Motion carried.

Brad Schoen, Director Riley County Police Department, Discussion with Governing Body and Citizens.

Schoen discussed active shooter training that is available to citizens if they want to participate. He also discussed the hiring process that is underway for his replacement as Director of RCPD and answered any questions from the Governing Body and citizens in attendance.

Gary Stith, Flint Hills Regional Council; Present Proposal to update Comprehensive Plan for Ogden.

Stith presented the Council with a proposal to update the City's Comprehensive Plan at a cost of \$22,222. He commented that the Office of Economic Adjustment in the Department of Defense will fund \$20,000 of the cost and the City would be responsible for a 10% match of \$2,222.

Burch moved authorize the expenditure of \$2,222 and to authorize the Mayor to enter into a contract with the Flint Hills Regional Council to perform an update to the City's Comprehensive Plan. Seconded by Reid. Motion carried.

Discussion of Fireworks Sales and Permitting Process.

Consensus of the Council was to have attorney Irvine draft an ordinance amending 7-305 of the fireworks ordinance removing only bona fide 100% non-profit charitable organizations

existing within the city are permitted to apply for a permit to sell fireworks and to change the permit fee to \$250.

Discussion of parking in front of Post Office.

Rohlman presented the Council with a proposal to designate three spaces in front of the Post Office as "Post Office Parking Only from 10 a.m.-4 p.m."

Consensus of the Council was to have city staff get signatures of neighboring businesses of who were for and who were against the proposal and present it at the next Council Meeting.

Bills of the Month.

Burch commented that he has reviewed the Bills of the Month and found them to be acceptable.

Ward Nations, City Foreman, and Approval of Expenditure to expand Pole Barn.

Nations presented the Council with a proposal to build a 4 bay pole barn in the shop yard for storage of city equipment at a cost of \$1800.

Carroll moved to authorize the expenditure of \$1800 to build a pole barn. Seconded by Burch. Motion carried.

Executive Session; Discuss an employee's performance; Pursuant to Non-Elected Personnel.

Carroll moved to recess into Executive Session until 8:20p.m Seconded by Burch. Motion carried.

Burch moved to return to Regular Session. Seconded by Carroll. Motion carried.

Burch moved to return to Regular Session. Seconded by Rohlman. Motion carried.

City Foreman: Misc. Items.

Nations commented that he is replacing the water line in the 300 block of 9th St. and is needing to purchase 240 feet of 6" water pipe and the cost is \$1053.60.

Carroll move to authorize \$1,053.60 for the purchase of 240 feet of 6 inch water line. Seconded by Burch. Motion carried.


